 - i. In support of age proof, candidates will have to submit school leaving/Matriculation/ Secondary Board Certificate / Certificates of Birth from concerned Municipal Authorities.
 - ii. Educational Qualification certificates (SSC, 10+2, Certificates/Provisional certificate/Degree/ PG degree/Diploma and mark sheets of all semesters /years as applicable).
 - iii. All certificates/documents related to work experience.
 - iv. Certificate of Competency issued from the competent authority wherever applicable as per the advertisement.
 - v. Wherever applicable, caste certificate of Scheduled Caste/Scheduled Tribe/ Other Backward Class (non- creamy layer) issued by the Competent Authority in the format prescribed by GOI (Copy of formats available on MOIL website). Candidates belonging to OBC - Non Creamy Layer are required to submit caste certificate from the Competent Authority, issued within one

year.

- vi. Income and Asset Certificate issued by a Competent Authority in the prescribed form available in our website (applicable for EWS candidates only).
- vii. Applicants working in Central/State Government/PSUs/Institute shall submit No Objection Certificate from current employer.
- viii. Any one of the following valid photo ID Card (i) Passport, (ii) Driving License, (iii) Electoral Identification card (iv) Aadhaar Card (v) Company's ID card.

Note: In case, if any of the certificates are not in Hindi, English or Marathi a self-certified translation of the same shall also be submitted.

If any candidates do not produce any of the above mentioned documents which are required for determining eligibility for document verification, his candidature will not be considered for further recruitment process.


