

Sub : MOIL SCHOLARSHIP FOR MERITORIOUS STUDENTS.

Management is pleased to introduce a new scheme called “MOIL SCHOLARSHIP FOR MERITORIOUS STUDENTS”. The Scheme has been devised to provide SCHOLARSHIP for bright sons / daughters of MOIL employees on the basis of their academic performance. This has been instituted to recognize talent and at the same time, to create a sense of competition among students.

(A) The norms are as follows :

1) The Scheme is called “MOIL SCHOLARSHIP FOR MERITORIOUS STUDENTS .

2) The Scheme is introduced from the Academic year 1995-96.

3) The Scheme is applicable only to the children of permanent employees of MOIL.

4) The Scheme is applicable to those who pass the qualifying examination, in all the subjects prescribed, in the very first attempt.

5) The Scheme is not applicable to those who are either gainfully employed or Carrying on any business or for married daughters of an employee.

6) Only 12 Scholarships, based on ranking as per the scheme, will be awarded
Every year 8 for S.S.C. (10th standard) and 4 for H.S.C. (12th standard)
Students.

7) In case no eligible student is available, the scholarship will not be awarded
for that year for examinations referred to in Clause 6 above.

8) The amount of SCHOLARSHIP will be Rs.100/- per month, payable
Quarterly, in arrears.

9) The amount of SCHOLARSHIP shall continue to be paid until one of the
parents of awardee continues to be in the employment of MOIL.

- 10)The SCHOLARSHIP once awarded shall be tenable for the entire period of The course of studies undertaken ending with the examination for the National Trade Certificate (ITI)/Diploma/Degree provided that the recipient passes successively at the first attempt, in all subjects, leading to the Certificate/Diploma/Degree. The awardee has to maintain high proficiency throughout the course of studies.
- 11)Should the Scholar discontinue his/her studies, the Scholarship awarded Stands cancelled.
- 12)The candidate who has been held eligible for award of the MOIL SCHOLARSHIP SHALL INTIMATE TO moil Management through the Head of the Institute of his/her having joined the same.
- 13)The medium of instructions is no bar.
- 14)The Scheme will be reviewed every year from its introduction and management reserves the right to modify/revised and/or withdraw the scheme totally in case it is observed that it does not serve the purpose for which it is introduced. The decision of Management shall be final.

(B) ELIGIBILITY :

Those who pass the following examination held in the first half of the year and in the first attempt.

S.S.C. or its equivalent examination with 60% marks in aggregate.

AND Prosecutes his/her further studies in an institute recognized by the Govt./College affiliated to any University leading to HSC/National Trade Certificate (ITI in any trade/Diploma in Engineering, H.S.C. or its equivalent examination with 60% marks in aggregate.

AND Prosecutes his/her further studies in an Institute recognized/College affiliated to any University leading to Degree course in engineering or medical (M.B.B.S.)

(C) PROCEDURE :

- 1) The applications for grant of Scholarship will be invited by the Head of the Units, and Personnel Department in the Corporate office at Nagpur, in the month of June/July or after the declaration of the result of S.S.C. and H.S.C. examination every year. The applicants from Mines will be forwarded to General Manager (Personnel) duly scrutinized & verified by the Mine Managers. The information to be furnished by the employee in

respect of his children shall be in the format attached as Annexure-I.

- 2) For claiming the amount of Scholarship from the Company the ward of the employee concerned shall submit an application addressed to the General Manager (Personnel) through Head of the Department/ Mines where his parent is working in the format attached as Annexure-II. Alongwith his application, he has to submit a certificate from the Head of the College/Institute regarding his performance in the format attached as Annexure-III.
- 3) The Scholarship once awarded shall be tenable for the entire period of the course of studies undertaken ending with the examination for the National Trade Certificate (ITI)/Diploma/Degree provided that the recipient passes successfully at the first attempt in all subjects leading to the National Trade Certificate/Diploma/Degree. The awardee has to maintain high proficiency throughout the course of studies. For this purpose, he has to furnish a certificate from the Head of the College/Institute at the end of each academic year in the format attached as Annexure-IV.

(D) SAVING :

For any matters pertaining to this scheme, the decision of the Management will be final and no appeal shall lie against the decision of the Management with regard to any aspect of the scheme.
