 - iii. All certificates/documents related to work experience.
 - iv. Certificate of Competency issued from the competent authority wherever applicable as per the advertisement.
 - v. Wherever applicable, caste certificate of Scheduled Caste/Scheduled Tribe/ Other Backward Class (non- creamy layer) issued by the Competent Authority in the format prescribed by GOI (Copy of formats available on MOIL website). Candidates belonging to OBC - Non Creamy Layer are required to submit caste certificate from the Competent Authority, issued within one year.

 - vii. Applicants working in Central/State Government/PSUs/Institute shall submit No Objection Certificate from current employer.


