MOIL achieves 45% production growth in Apr-Oct '23

Sales higher by 57%

Record calendar year production achieved in 10 months (Jan-Oct)

MOIL's production has surged to 9.26 lakh tonnes in the first seven months of FY23, registering a remarkable growth of 45% over CPLY. In October 23, the company achieved a production of 1.11 lakh MT, which is 48% higher y-o-y.
